Privacy Statement

These notes provide information about how your personal data is processed by Dorotheum GmbH & Co KG for the Auctions Department, as well as about the rights to which you are entitled under data protection law. 2. Purposes and legal bases of data processing for the Auctions Department

a) We process your personal data in accordance with the data protection regulations of the EU General Data Protection Regulation (GDPR), the Austrian Data Protection Act (DSG) and all other laws applicable to our Auctions Department. In particular, these include the Commercial Code concerning the purchase and sale as well as public auctions of movable property (§ 158 GewO 1994 as amended) and the arms trade (§ 139 GewO 1994).

b) If you wish to place an order for the purchase, sale, generation of an estimate, storage or public auction regarding movable objects (such as fine art, antiques and collectibles, as well as jewellery and commodities of all kinds) or participate in an auction organised by us (including online auctions), we require the information provided by you for the conclusion of the purchase, sale or brokerage contract (commission business), including all the associated ancillary services such as the generation of an estimate and/or storage regarding the abovementioned art and commodities, in particular, as well as the processing of auction logistics. If a contract is concluded, we process this data for the implementation of the contractual relationship.

It is not possible to conclude or execute a sales contract, commission contract or storage contract in accordance with our General Terms and Conditions for Auctions (https://www.dorotheum.com/de/c/agb-47/) without your personal data being processed.

The legal basis for this processing of personal data for both pre-contractual and contractual purposes is Article 6(1)(b) GDPR. The processing of special categories of personal data is not

c) In addition, we need your personal data (with your consent [Art. 6(1)(f) GDPR]) to provide communication channels as a service for registered users in accordance with the terms of use for myDorotheum (https://www.dorotheum.com/de/c/mydorotheum-269/) and/or as a customer. The legal basis for processing in this case is the respective statutory provisions in conjunction with Art. 6(1)(c) GDPR.
- f) Should we wish to process your personal data for a purpose not mentioned above, we will inform you of this beforehand, within the framework of the statutory provisions.
- g) You are not subject to any automated decision that has any legal effect on you

4. Duration of data storage

against our company (statutory limitation period of thirty years), as well as for contractual documentation and proof of ownership. In addition, we store your personal data insofar as we are legally obliged to do so. We will delete your personal data as soon as it is no longer required for the above-mentioned purposes. Personal data may be retained for the period during which claims may be asserted

Corresponding duties of proof and storage result, among other things, from the duties of care under the Cultural Property Return Act (§ 9 KGRG), which also provide for a storage duty of 30 years in order to make the cultural property and its contributor identifiable, including the purchase and sales prices, the Commercial Code, the Tax Code and the provisions of commercial law to prevent money laundering and terrorist financing. The storage periods are at least five and seven years respectively.

You can request information regarding the personal data stored about you from the above address (and also by email to client.services@dorotheum.at, after successful identification), provided that the provision of this information would not endanger a business or company secret held by the controller or third parties (§ 4 para. 6 DSG). In addition, you can request your your data be corrected if we have stored incorrect data about you. You also have the right to request the completion of your personal data if we have stored incomplete data, taking into account the purposes of the processing. In addition, under certain circumstances, you may request that your data be deleted, provided that no legal requirements are violated in so doing. You may also have a right to limit the processing of your data and a right to have the data you provide disclosed in a structured, common and machine-readable format.
